In Germany, Austria, Romania and Slovakia, people with learning difficulties or disabilities have tested these learning materials in workshops. The results were improved with the findings from these tests. They are now finally developed and available.

All results cover the topics: Climate, Food, Biodiversity, Consumption, Mobility.

The **EFDI Curriculum** is a collection of methods and serves as a learning programme for inclusive learning.

#### The EFDI Guidelines for Community Experiences

addresses environmental issues based on experiences in the community. In this way, bridges are built between people with disabilities and communities. They learn together about environmental and sustainability issues.

The **<u>EFDI Campaigning Set</u>** shows people how they can start campaigns for a better ecological future. People with intellectual disabilities learn how they can become active and participate in democratic life.

In the **EFDI Multisensory Art Book and Toolbox** you find sensory-orientated learning materials on the topics of ecology and climate protection.

All results contain illustrations for better understanding.

#### **END OF THE PROJECT – FINAL CONFERENCES**

At the end of the project, EFDI conferences were held in all partner countries. A conference is a meeting of many people who are interested in a topic. Invited experts talk about this topic or present a project.

In **Graz, Austria**, around 80 people attended the conference on the 9th November. It was supported by the illustrator who drew all the illustrations for the results of the project.

In **Bukarest, Romania**, the final event brought together 55 people: people with intellectual disabilities, representatives of organisations working with people with disabilities and students from the University of Bucharest.

The event consisted of the presentation of the project and its results, as well as a practical upcycling activity.

In **Munich, Germany**, 33 people attended the conference on the 28th of November. All participants were very interested in the materials. They had a lot of fun trying them out and would like to use them actively in the future.

In **Bratislava, Slovakia**, the final conference took place on the 12th of December. 57 participants included people with multiple disabilities and employers of home of social services, but also students, people working in early intervention or in schools. The presentation was followed by a practical activity - multisensory baking of Christmas cakes with local ingredients.
